**Registration fee for the Mr. Trans USA pageant:**

**Jan 1st** the registration fee is \$300

**Feb 1st** the registration fee is \$350

**Mar 1st** the registration fee is \$400

**Mar 31st** registration will close

**\*To be eligible for the discounted rate of \$300 your payment and registration form must be mailed together and postmarked within the respective dates. If you send in \$350 AFTER Feb 28 you will have an unpaid balance due of \$50.**

## **Mr. & Miss Trans USA Rules and Regulations**

Welcome to the 2022 Mr. & Miss Trans USA National Pageant!

We are thrilled that you have chosen to become a qualified contestant in the Trans USA National Pageant! You will not find a more trans-inclusive, fair, and vibrant pageant in the circuit. This is truly a pageant where the best contestant overall will win regardless of where you come from, what your name is, or whether or not you have competed nationally in the past.

This handbook will give you information needed to be prepared for the competition and an outline of how things will be run. PLEASE READ EVERYTHING CAREFULLY.

### **Judging/Scoring:**

Contestants will be scored

- Interview and Evening Gown/ Evening Wear - 1st place gets 60 pts., 2nd place gets 58 pts., 3rd place gets 56 pts., etc.
- State costume and Swim Suit - 1st place gets 40 pts., 2nd place gets 38 pts., 3rd place gets 36 pts., etc.
- Question and Answer – 1st place gets 20 pts., 2nd place gets 18 pts., 3rd place gets 16 pts., etc.

Each contestant will also receive a comment sheet from each judge and a copy of their individual master score sheet. Contestants can pick up their comment sheets and score sheet before leaving the venue immediately after the pageant in the dressing room. If you choose to share your scores publicly after the pageant that is your right. We reserve the right not to post everyone's scores because we believe in keeping the experience professional and are sensitive to your privacy. If you wish to see the master score sheet for yourself you may do so in person after the pageant while under supervision. No pictures of the overall master score sheets are allowed. Your dresser may accompany you to view the master score sheet.

Evening Gown/Evening Wear Description Forms will be given out and collected at registration as well as your written bio.

They **MUST** be turned in at Registration or you will not have a description/bio read.

### **Admission/Dressing Areas:**

**Contestants only will not pay for admission to the venue. All dressers, prop personnel, managers, lovers, etc. must pay applicable admission.**

Contestants will be sold one backstage pass for a dressing room assistant during registration. It will allow one person to enter the dressing room with you to assist. **NO EXTRA** helpers will be allowed in the dressing area. If you have more than one

assistant, only one may enter at a time and must use the same backstage pass for dressing room access.

Please be respectful to the dressing area rules. There are rules for a reason and you are asked to follow them or be held accountable for the consequences.

ANYONE with more than one dresser at their side at a time will lose administrative points for violating this rule after an initial warning. This procedure is designed to make the dressing areas a comfortable working space and to protect all contestant's property.

### **Administrative Points:**

One (1) administrative point will be deducted per judge in the following manner: Please remember there will be 5 judges

- Contestant does not enter the stage at appointed time and delays the presentation of the pageant.
- Each 10-minute interval the contestant is late for any/all scheduled events.
- For any friend or dresser not wearing the designated name badge accompanying the contestant into the dressing room. All points removed will be at the discretion of the head judge. If any given judge wishes to penalize a contestant they must bring it to the attention of the head judge and the points will then be deducted by the head judge if the infraction is validated.

### **IMMEDIATE DISQUALIFICATION AND OR**

#### **PERMANENTLY BANNED FROM THE Mr. & MISS TRANS USA PAGEANT:**

- Contestants leave the stage before or during crowning, before being dismissed.
- Theft or vandalism to any property.
- Knowingly allowing others to enter the host location without paying an applicable admission fee.
- Any irreparable remarks made toward or regarding a Miss Trans USA contestant, Promoter, Board Member, Title Holder, Past Titleholder, or Judge.

#### **THREE YEAR DISQUALIFICATION AND BAN FROM ENTERING, JUDGING, OR ENTERTAINING AT ALL MR. & MISS TRANS USA FUNCTIONS:**

- Contestants drop out of the competition after the registration end date of May 27st.

## **Rules & Regulations**

The Mr and Miss Trans USA Pageant is NOT a “drag” pageant, but a competition to highlight transgender persons that include non-op, pre-op, post-op, and non-binary individuals.

1. All Miss Trans USA contestants must have been assigned male at birth (AMAB).
2. All Mr Trans USA contestants must have been assigned female at birth (AFAB).
3. Must be at least 21 years of age by the national pageant registration date.
4. Interview will be limited to 10 minutes. State Costume will be limited to 3 minutes. If the time limit for said category is exceeded then you may be deducted administrative points.
5. Due to dressing area limitations there is to be only 1 assistant backstage. If there is more than 1 person they will be asked to leave the dressing room. If the person does not leave when asked or is found backstage again administrative points will be deducted from the final score of that contestant. Contestants have to pay for dresser passes at a presale ticket price of \$15 which includes a seat designated in the back of the venue. The helper passes will be available for purchase during registration. Standing in the audience will not be allowed. Everyone has a paid seat in the audience covered.
6. The use or dispensing of any illegal substance will not be tolerated while any contestant is participating in the pageant. Immediate disqualification and ejection from the venue will occur for anyone breaking this rule. Excessive consumption of alcoholic beverages by the contestant or contestant helpers, will also result in disqualification if more than one verbal or a written warning is given by a Trans USA board member.
7. Any Contestant not in the appointed place at the appointed time (i.e. Interview, Contestant Check-In, etc.) will have a 1 point per judge deduction for every 10-minute increment.

8. Any Contestant or helper who is caught in the act of stealing or tampering with another person's property will be ejected from the premises and will be immediately disqualified.

9. Trans USA does not discriminate against competitors with silicone or those who participate in hormone therapy.

10. No exposed breasts, areolas, buttocks, pasties, genitalia or tape will be allowed. No exceptions.

11. The winners of the Mr. & Miss Trans USA Pageant must sign a legal contract agreeing to fulfill their duties as the reigning Mr. or Miss Trans USA for one year or relinquish the title, pay back all monies paid by the pageant owner and return the crown. Also, the winner must agree to appear and relinquish the title and crown at the end of the reign if the reign is completed.

12. Trans USA reserves the right to make any decisions concerning any matter not covered by these rules and regulations.

• **Mr. Trans USA Winner:**

Mr. Trans USA will receive: the official Mr. Trans USA medallion & sash, and will receive \$2,000 cash, up to \$2,000 during reign in accommodations.

**PAY SCHEDULE FOR WINNER:** \$1000 at crowning, \$100 after 30 days pending approval of official promo, \$400 6 months after winning , and \$500 at the next

Mr. Trans USA National Pageant (step down).
